

# Pilton Village Trust

## Treasurers Report and Year End Accounts (24-25)

## Overview:

The financial position of the Trust continues to be strong, with £26458.05 in our accounts at the end of this financial year, split as follows:

- A current account balance of £15287.89
- A savings account balance of £11170.16

We generated £16713.23 of income, and our spending was £19651.76.

In this period the trust was in receipt of a contribution of £2'767.18 from the Pilton Stage Ltd..

In the period since the last financial report, the trust has moved £10033.14 of its savings account balance to the current account to fund needed maintenance works.

A full breakdown of income and expenditure is included in this report.

## 24-25 FY Specific Considerations:

### Insurance:

The trust spent £3500.42 on insuring its premises.

### Legal Fees:

The trust spent £3840 on legal fees in the period, related to the implementation of the Pilton Stage management model.

### Non-recurring costs:

Works were required to the windows, and to return some of the plant equipment in the building to serviceable condition. In addition to this the trust incurred costs related to the recommissioning of the electrical supply. These costs are detailed in the report, and totalled £9369.80

## Risks and Opportunities FY 25-26

### Overview:

While our current position remains good, we need to be mindful of potential impacts to the Trust financial position in the next financial year – I have provided a quick summary of the current risks and opportunities below.

### Risks:

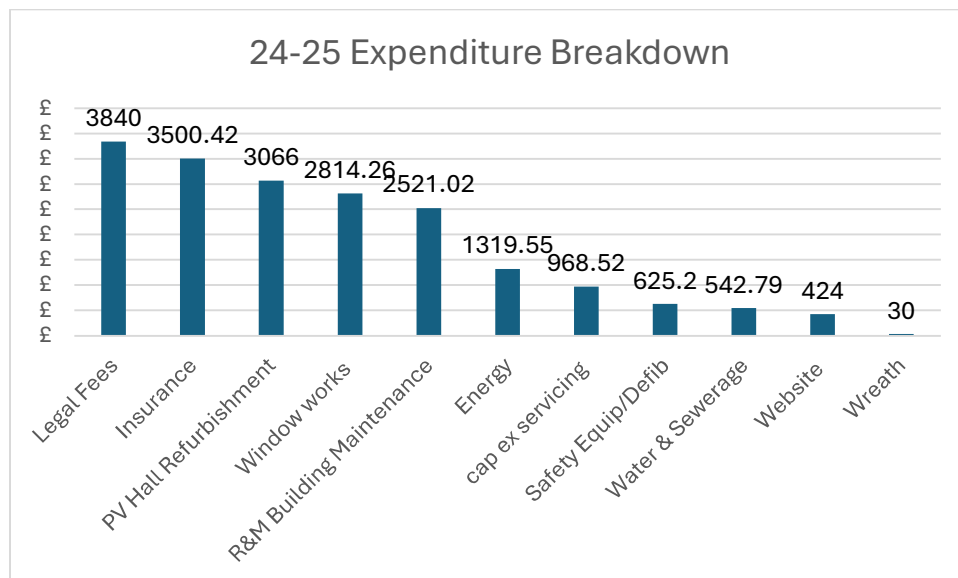
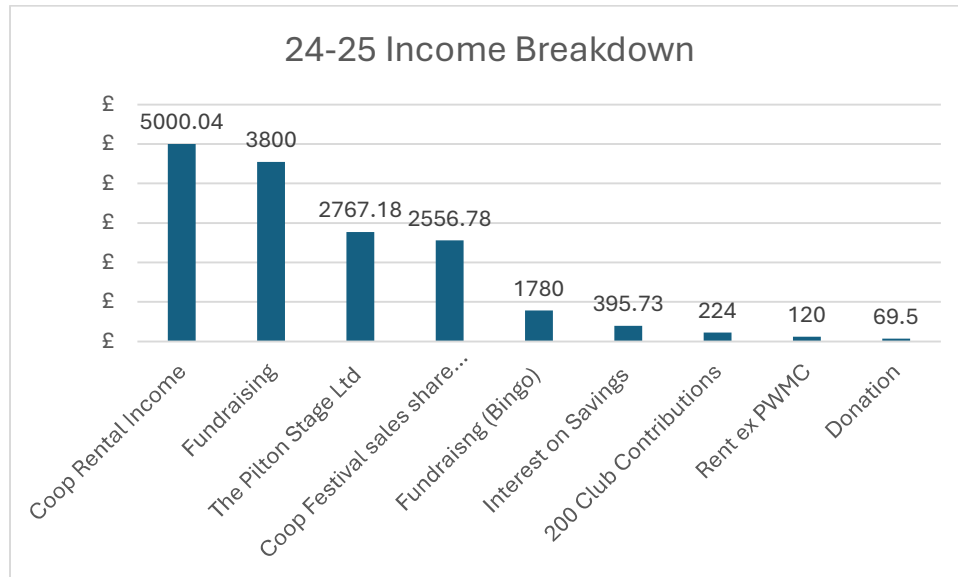
- Some works will be required to the roof of the building in the next term following an inspection of the premises. Quotes are being sought for the work.
- The Lease for the Co-Op is due for renewal in the next period.

### Opportunities:

- The Trust will be in receipt of both a service fee from the Cooperative, and a payment related to the sale of their own brand products from their on-site store at the 2025 Festival.
